ENERGY STAR[®] benchmarking for California AB-802

Are you keeping up with the energy benchmarking required by California Assembly Bill 802 (AB-802)? We can help!

On June 1, 2018, California began enforcing AB-802, which mandates the disclosure of information on building energy consumption for commercial buildings. As of June 2019, residential buildings are now included in this regulatory requirement.

Regulation

Under AB-802, any property with a gross floor area greater than 50,000 sq. ft. (commercial, residential and mixed use) must obtain an ENERGY STAR score using ENERGY STAR® Portfolio Manager®. If you are unsure whether your property is required to report, Yardi can help you confirm the details and timelines you need to know.

AB-802 includes public disclosure of your energy score. This means your property's energy use will be visible to current and prospective tenants — making accuracy and timeliness critical to your success.

Implementation

Phased implementation of the regulation is as follows:

Phased Mandatory Reporting Timeline	Commercial Properties	Multi-Unit Residential
By June 1, 2018 Information for 2017 calendar year	50,000 square feet and larger	Voluntary reporting in first year
By June 1, 2019 Information for 2018 calendar year	50,000 square feet and larger	50,000 square feet and larger
By June 1 for all subsequent years Information for prior calendar year	50,000 square feet and larger	50,000 square feet and larger
