## Required Supplemental Terms and Conditions for Pre-Qualification Services

This Schedule (Required Supplemental Terms and Conditions for Pre-Qualification Services) replaces in its entirety all earlier revisions of these terms, however named, and whether contained in a schedule or that were otherwise part of Client's or Property Manager's screening agreement(s) with RentGrow, Inc. (the "Agreement(s)") and is fully incorporated therein per the terms of said Agreement(s).

NOTE: For purposes of all terms and conditions in this Schedule only: (a) all references to "Qualified Subscriber" and "Subscriber" shall mean and refer to Client, Property Manager and End-User as those terms are defined in the Agreement, as applicable; and (b) all references to "CRA" shall mean and refer to RentGrow as defined in the Agreement, as applicable.

- Client acknowledges that RentGrow will maintain a record of each Pre-qualification Consumer's written instructions stating
  that the Consumer consents to the pre-qualification screening in a form that is substantially similar to the language set forth
  in Exhibit A hereto and in a form that is capable of being accurately reproduced for later reference by RentGrow or Experian.
- 2. Client acknowledges and agrees that it shall not:
  - a. Operate as the agent of any third party in connection with the Pre-qualification Services;
  - b. Operate as a reseller of the Pre-qualification Services;
  - Directly or indirectly charge applicants any costs or fees, or accept any payment or valuable consideration from
    consumers in exchange for the Pre-qualification Services or any information derived from the credit information
    provided in connection with the Pre-qualification Services;
  - d. Offer the Pre-qualification Services or credit information as the sole additional feature of a higher-priced service offering or as an incentive to or bundled with a fee-based offering;
  - e. Use the Pre-qualification Services to replace the application and tenant screening process, including using the Pre-qualification Services to replace a hard inquiry to evaluate a rental application;
  - f. Use, or permit any of Client's employees, agents, or subcontractors to use, trademarks, service marks, logos, names, or any other proprietary designations of Experian, whether registered or unregistered, without prior written consent from Experian;
  - g. Offer depersonalized credit profiles using credit information obtained from the Pre-qualification Services for bid by third-parties;
  - h. Provide any credit information obtained from the Pre-qualification Services to any consumers or third-parties, or provide a credit score, decision, or any other information or indicator of the consumer's creditworthiness to the Pre-qualification Consumer or any third-party except as necessary to provide notice of adverse action to consumers pursuant to the FCRA;
  - i. Make any credit decision or provide FCRA-regulated pre-screen on behalf of a third-party.
